Transport Rules :

1. Bus facility will be provided on first cum first serve basis
2. Parents should consult the school transport in charge for necessary details of bus routes or any changes if desired.
3. Parents should ensure that their wards are always escorted to and from bus stops. For children who, for any reason have to travel unescorted to and from their stops, an application mentioning same must be sent to the Principal.
4. A student using the school bus is expected to be at the bus stop at least five minutes before the scheduled arrival of the bus. The student has to be on the correct side of the arriving bus.
5. Please do not over take or stop the school bus to facilitate the boarding of your ward as it endangers the safety of the children.
6. Please do not get into an argument with the teachers, conductor or driver present in the bus. In case of problem, please give written complaint to the school office.
7. The drivers are authorised to stop buses at designated stops only, unless otherwise directed by the I/C-Transport and Principal.
8. Students are allowed to use only their allotted bus and bus stop. There is no provision for temporary change in buses or bus stop.
9. For their own safety, students are not allowed.
 - * to touch the instrument panel of the buses.
 - * to keep their hands out for waving.
 - * to throw any object inside or outside the bus.
 - * to shout in buses as it distract the driver.
10. Students must make sure school bags and other belongings are properly placed in the bus.
11. The consumption of edibles and drinks is not permitted in the bus.
